
## IDC Breakout Board

2 mm IDC Breakout Board for Single-Board RIO Devices

This document contains installation instructions for the IDC Breakout Board for sbRIO.

## Installing the IDC Breakout Board

You can install the IDC breakout board directly to a Single-Board RIO device or to a Single-Board RIO/NI 9694 assembly.



What to Use

- IDC breakout board
- 50-pin IDC cables
- Single-Board RIO device (user provided)
- NI 9694 (optional)
- Mounting hardware (user provided)




**Note** Mounting holes on the Single-Board RIO device are designed to accommodate M3 or 4-40 fasteners, and standoffs or bosses up to 4.5 mm or 3/16 in. in diameter.

## What to Do

Complete the following steps to install the IDC breakout board.

1. Align the devices and secure the assembly using the mounting hardware.



- 1. Installing directly to a Single-Board RIO device.
- 2. Installing to a Single-Board RIO device/NI 9694 assembly.
- 2. Connect the MIO connector on the Single-Board RIO device to the MIO connector on the IDC breakout board and the DIO connector on the Single-Board RIO device to the DIO connector on the IDC breakout board using the 50-pin IDC cables.
